

Privacy policy

This Notice, provided pursuant to art. 13 of EU Regulation 679/2016 - hereinafter referred to as GDPR - serves the function of informing the visitor of the site www.pedrotec.com with regard to the processing of data obtained by browsing. The processing of the data carried out is based on the principles of correctness, lawfulness, transparency and protection of privacy and visitor rights as provided for in the aforementioned GDPR. Type of data processed

Processing of personal data, within the meaning of the Law, means any operation or complex of operations, carried out with or without the aid of electronic or automated means, concerning the collection, registration, organization, storage, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, dissemination, deletion and distribution of data.

1. Data obtained from the navigation

www.pedrotec.com uses technical cookies that do not require prior authorization from the user, as they do not carry out profiling and anonymize the data capable of identifying the user. In fact, our computer systems and software procedures for the operation of this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. This category of data includes the domain names of the computers used by users who connect to the site, the addresses in URI (Uniform Resource Identifier) notation of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numeric code indicating the status of the response given by the server - good end, error, etc. - and other parameters relating to the user's operating system and IT environment. This data is used for the sole purpose of performing the proper operation of the website itself.

Purposes of processing and their legal bases of lawfulness

The data obtained by browsing will be processed legitimately by legal obligation arising from the Internet communication protocols

Method of treatment

Personal data are processed electronically in full compliance with the GDPR, including security and confidentiality profiles and inspired by the principles of fairness and lawfulness of processing. Personal data are stored and processed through computer systems owned by the Company and managed by the Company. The Company undertakes to protect the security of your personal data and complies with the security provisions laid down by applicable law in order to avoid data loss, unlawful or unlawful use of data and unauthorized access to them. In addition, the information systems and computer programs used by the Company are configured to minimize the use of personal and identifying data.

Nature of the data provision

The provision of data obtained from navigation is mandatory and implicit to the operation of web communication protocols.

Data transfer and communication

Your data will not be disseminated or transferred to non-EU countries. Your data may be processed, during the extraordinary maintenance of the website, by our supplier who is responsible for the maintenance of the website, as Data Controller.

Treatment times

The treatment will be carried out for the session period of navigation.

User rights

The user can exercise at any time the rights recognized by artt. 15-22 of the GDPR, including: access to personal data relating to him, as well as the rectification, cancellation, limitation, opposition to their processing and portability of the same, where processed automatically on the basis of consent or for the execution of the contract. The data subject has the right to revoke the consent at any time without prejudice to the lawfulness of the processing based on the consent given before the revocation. The data subject has the right to lodge a complaint with the Guarantor Authority for the processing of personal data, pursuant to art. 77 of EU Regulation 679/2016.
